## **Dear City Council,**

I am an s22(1) Personal and Confidential staff in Kitsilano. I'm also a longtime renter in Kits. Please consider the following when making your decision on the Arbutus project!

#### Need for more social housing in general

• If the city isn't building social housing on the land that it owns, where no existing residents would be displaced, where will it build?

## Need for social & supportive housing in all neighbourhoods

 There's a <u>30 year gap in life expectancy</u> between different neighbourhoods in Vancouver, and we need social and affordable housing to be spread out throughout the city.

#### Location

- It makes sense to have social housing beside a new skytrain station. This is also aligned with the city's climate goals.
- Residents at the building can enjoy access to transit, arbutus greenway, etc.

#### All Housing is beside Parks & Schools!

- The majority of supportive housing in BC is within 500 metres of a school with few issues. This is because our neighbourhoods are designed around schools!
- The way we've designed our cities means that all new social housing can only be built near parks and schools - otherwise, buildings would be in industrial areas, which is inhumane.

## **Unhoused Neighbours in Kitsilano**

- A large number of seniors are experiencing or at-risk of homelessness in Kitsilano with nowhere to go
- Members of the LGBTQ2S+ community are disproportionately at-risk of homelessness. Social housing aligns with the City's goals around equity.
- Many people are just a few paycheques or unexpected challenges away from housing insecurity, especially during a housing crisis.

#### **Building Design**

- This isn't "warehousing people" each unit is a studio apartment with its own bathroom. Amenities will also include kitchens and community meals, dining areas, programming spaces. These will be nice homes!
- Lots of people around Vancouver live in studio apartments

# **City Commitments**

- Approving this building is directly in line with the election commitments councilors made to solving the affordable housing crisis
- It also aligns with policies that Council has passed. Including: City of Reconciliation and Affordable Housing Policy.
- The City's Affordable Housing Policy explicitly talks about: "maintaining and expanding housing opportunities for low and moderate income households; encouraging the distribution of housing equally among residential neighbourhoods".
