Re: CD-1 REZONING: 2086-2098 West 7th Avenue, and 2091 West 8th Avenue

As Vancouver community members who form the City's Women's Advisory Committee, we write to express our collective support for CD-1 REZONING: 2086-2098 West 7th Avenue and 2091 West 8th Avenue, which would permit the development of a 13-storey residential building containing a total of 129 social housing units. The Rezoning Proposal will add critical supportive and affordable housing for community members, including vulnerable women and other people of marginalized genders. The pandemic has highlighted and amplified the barriers and inequities that are affecting equity-seeking and marginalized folks. One of the major barriers to reducing inequities in the City is access to safe and affordable housing. The rezoning proposal would provide safe and affordable housing for those who are experiencing or are at risk of homelessness or displacement. According to the City of Vancouver's most recent homeless count, there are more than 2000 people across the City who are currently experiencing homelessness. Many of them are women, 2SLGBTQ+ folks, youth, and seniors.

Additionally, the location for the Rezoning Proposal is ideal for social housing as it is close to a future transit station and various amenities. This will help residents access schools, employment opportunities, medical services, and other social services.. More accessible social and affordable housing spread throughout the City will also help victims of gender-based violence. Lack of access to safe and affordable housing is a barrier for many trying to leave violent partners.

We acknowledge there is significant concern among residents of Kitsilano regarding the location, with some citing concerns over safety of residents and in particular children attending a nearby school. Among our committee members are parents of school-aged children, including children who have been raised in more urban areas, who feel that these concerns expressed are exaggerated and could be addressed through community involvement and engagement. We also encourage the City to consider how to mitigate resident concerns by ensuring residents of the social housing development are provided all necessary supports to thrive, integrate and establish strong social support networks within the Kitsilano community.

The City of Vancouver has a mandate to reduce the affordability gap, as articulated through the "Housing Vancouver" policy. This includes supporting non-profit and non-market affordable housing options. The Rezoning Proposal will help the City move towards realizing this commitment. There are already many individuals experiencing homelessness in Kitsilano who need immediate access to safe housing. We expect a silent majority of Kitsilano residents, property owners, businesses, and workers would look forward to welcoming new community members into their new home at 2086-2098 West 7th Avenue and 2091 West 8th Avenue.

Council approval of the Rezoning Proposal would demonstrate that the City is serious about taking leadership and responsibility for reducing barriers for its most vulnerable residents, especially as the cost of housing skyrockets. We urge you to approve this project's application for rezoning to improve access to affordable housing.
