I makes me sad to see so many people living rough outside, some of them right there on the Arbutus path, and it is really strange to me that some people seem to think that leaving people to live on the street without supports will make housed people 'safer.' When we all have homes, we are all safer, together. Many people who would benefit from this housing already live, unhoused, in our neighbourhood. My work in Kitsilano and Point Grey for the provincial MLA office means that I meet people who come looking for help with housing, but I also meet potential residents in the park, in the library using the internet, playing guitar in front of the Tim Hortons, and living in cars parked at the beach. Many people in Kitsilano and nearby neighbourhoods have fallen out of their rental housing that they have been in for years. A lot of them are seniors. A lot of them are single men. Some have some issues with addiction or mental health, and some do not—they are just low income and they are our neighbors. I don't agree that issues with addiction or mental health should preclude people from safe housing. It is extremely traumatic to live unhoused, and living with that level of insecurity compounds existing mental health issues, and is a huge barrier to having any kind of stability from which to rebuild a life. Nor do I think that everyone with mental health or addiction issues can or should be concentrated in the Downtown Eastside so that they can be out of sight of the good people of Kitsilano. People who are struggling with homelessness mostly want a quiet, safe place to live, just like people with homes.
