I was working on a detailed comment with supporting documentation but realized that your staff report and the answers to questions to staff ensure that you are well informed, as I was in my many years at City Hall. Thanks to my experience, I understand the implications and challenging pro formas of projects like this. I understand the need for supportive and subsidized housing across the city. I understand that housing people is always the better option than leaving them unsheltered. I also know that you are hearing many arguments that have been heard over and over at City Hall. Many of those arguments make assumptions that are untrue, and that are based on fear rather than facts. One of those arguments encourages you to let the perfect be the enemy of the good. This is good housing. A very good option. An option that will bring many people to a place where they can rebuild their lives. An option that is available right now. I write to you now as a neighbour. I will be able to see here continues to be more unsheltered residents in Vancouver than there are indoor shelter and housing options. Living outside is difficult and dangerous. I am strongly in favour of this project which will provide people who might otherwise be forced to reside in encampments with a warm, safe, dignified place to live. This project will displace no one, is fully funded by senior levels of government, and provides wrap-around services to residents, such as meals, healthcare services, access and referral to addiction recovery and mental health programs, Indigenous cultural programming, skills building, and connection to volunteer or employment opportunities. This project is appropriately situated next to rapid transit to allow residents to easily access any off-site services. In response to those who are concerned about the impacts this project will have on the social fabric of the Kitsilano neighbourhood - no neighbourhood should be deemed 'unsuitable' for supportive housing. As noted by city-staff 'there are no land use restrictions for low-income or homeless residents in City policies and homelessness occurs across the city.' It is clear that such a policy to the contrary - relegating housing insecure, low-income residents to only certain areas of the city (i.e. the downtown eastside) - is segregation. We cannot allow segregation to be pushed forward informally by allowing projects like these to be drowned out by vocal opposition any time they are proposed in neighbourhoods of wealth and privilege. A number of people who have written in to oppose the project have stated they are not against social housing per se, but instead, are concerned housing large numbers of at-risk individuals together in one space is detrimental to the individuals' health and recovery. 

I am a frontline social worker; resident of Vancouver; and someone who believes that housing is a human right. I am also someone who has never had their right to housing or desire to live in a specific neighbourhood be debated or voted on. I know that you have received hundreds of letters about this housing proposal. Before you vote, I urge you to ask yourself: Am I prepared to sit down with the next person I encounter who is experiencing homelessness, look them in the eye, and tell them that I had the opportunity to give them a home but chose not to, chose to delay, chose to wait for a 'better time', a 'better location' If not, then your decision is clear ' you must vote yes. When new low-income or supportive housing is being considered, it is often talked about in terms of voting on whether a project will be approved, land will be rezoned, or housing will be built. But that is not what you are voting on. Such language obscures the human faces and lives behind these decisions. You are not voting whether land should be rezoned to build this housing ' you are voting on whether vulnerable members of this community should have to continue sleeping outside, in unsafe conditions, where their lives are at risk. You are voting on whether people have the right to a home, in any part of this city, just as you and I 2018. In my time as a parent in this neighbourhood I have had to explain to my four-year-old why there are unhoused people in this neighbourhood. I won't pretend there are things about the housing crisis I wish I didn't have to explain to my child, but I also want my son to understand that living in a society means living with people with different experiences, including hardships, and that everyone deserves support and housing. I have seen the proximity of Delamont Park and the school nearby leveraged by opponents to this development as part of a moralizing case against building supportive housing on this site, and I want to respond here to that view in two ways. As a parent I am appalled that people think so little of children that they want to simply hide the double-standards of Vancouver from them. That some areas of the city can refuse to shoulder the burden for hosting those who need supportive housing, while others play host the preponderance. I know what my kid knows: Delamont Park is a great park, and I will keep taking him there so long as he has time for swings. But I would also like to speak to the cultural narratives leveraged against this proposed housing in the public hearings so far. Dear Councillor Swanson,

I am writing in support of the proposed supportive housing building at West 7th/West 8th and Arbutus. I am a frontline social worker; resident of Vancouver; and someone who believes that housing is a human right. I am also someone who has never had their right to housing or desire to live in a specific neighbourhood be debated or voted on.

I know that you have received hundreds of letters about this housing proposal. Before you vote, I urge you to ask yourself: Am I prepared to sit down with the next person I encounter who is experiencing homelessness, look them in the eye, and tell them that I had the opportunity to give them a home but chose not to, chose to delay, chose to wait for a “better time”, a “better location”? If not, then your decision is clear – you must vote yes.

When new low-income or supportive housing is being considered, it is often talked about in terms of voting on whether a project will be approved, land will be rezoned, or housing will be built. But that is not what you are voting on. Such language obscures the human faces and lives behind these decisions. You are not voting whether land should be rezoned to build this housing – you are voting on whether vulnerable members of this community should have to continue sleeping outside, in unsafe conditions, where their lives are at risk. You are voting on whether people have the right to a home, in any part of this city, just as you and I do.

Working as a frontline social worker with people who are experiencing homelessness, mental health struggles, and substance use, I have seen first-hand the incredible impact that having a home has on a person’s life. I have also seen the backlash, fearmongering, and stigmatization that comes alongside any proposed supportive housing. When Temporary Modular Housing was first proposed in Richmond, where I work, many people opposed to it spoke of feeling scared of the people who would live there. I remember how scared I felt during those discussions. Scared that discrimination would win. Scared that the housing

would not be built and people would have to continue waiting years for housing. Scared that people would be forced to remain on the streets. Scared that they wouldn't make it through another winter. I can only imagine how scared my clients must have felt as they waited while their human rights and basic human dignity were voted upon.

It was a relief when that housing was approved and 40 people moved from sleeping on the street to sleeping in their own beds. The fears of those who were opposed did not come true and soon, another supportive housing building will open and 40 more people will have a home. But my fears persist with the proposal before you now as I worry that people in the city where I live will not have access and opportunity to safe housing. I fear for the lives that will be lost as a result.

I urge you to approve this application without delay and make it clear that this is a city where everyone's lives are valued.
