I am writing to express our organizational support for the rezoning application for 2010 Harrison Drive.

BC Non-Profit Housing Association (BCNPHA) is the umbrella organization for the province's non-profit housing sector and is comprised of more than 500 members, many of which operate housing in Vancouver. As an organization focused on affordable housing, we are acutely aware of how desperately these proposed homes are needed in the neighbourhood and for residents of Vancouver overall.

The German-Canadian Benevolent Society of BC has owned this property for more than 50 years and has been a wonderful steward of this community asset. As the buildings are no longer viable and need to be replaced, this proposal includes a means for revitalizing and upgrading the site through the combination of a senior's care facility and rental housing.

With 187 seniors care beds, 61 market rentals, and 15 moderate income rentals on the table, it is clear this project will provide significant reprieve for hundreds of seniors and individuals throughout the lifetime of the buildings. We also know isolation poses a major risk to the wellbeing of seniors and this project's inclusion of a European small house model should ensure that future residents will be able to build community to collectively combat loneliness and increase autonomy.
