The River District was designed to be a walking community without needing a vehicle. However, the River District lacks social amenities, transportation, and schools. Seniors are having a more challenging time accessing or getting their social, emotional, and physical needs met because they need a car, walk up Kerr (a large hill) or take a bus to a centre. The neighbourhoods of Sunset, Victoria-Fraserview, and Killarney consist of over 100,000 people: this represents approximately 1/6 of the overall population of Vancouver. Homes between Argyle Street and Boundary Road below Marine Drive are more than 95% apartments or townhomes. South Vancouver has a high density of seniors (16% of the population), the largest household sizes and the highest percentage of households with children at homes. Based on our participant surveys, 100% of the seniors that live in the River District area have identified barriers to accessing community programs/supports related to social interaction, mental health, community meals, access to senior services, etc. due to the lack of resources in the area. SVNH works closely and provides programs in the community centres (i.e., Kilarney, Sunset, Champlain) to address seniors String Community and Better at Home programs. These programs support seniors to maintain healthy liffestyles at home. Hence the importance of creating a community centre (within walking distance) that will address the needs to help seniors to thrive in. The fact that a community centre within walking distance of the seniors living below Marine Drive has the potential to increase physical activity and enhance the socio-emotional indential well being of seniors.
