SUBJECT: Amendments to City of Vancouver Policies

## RECOMMENDATION

THAT the Auditor General Committee endorse the Auditor General's recommendations contained in Appendix A of this report and recommend the policy changes to Council for approval.

## COUNCIL AUTHORITY/PREVIOUS DECISIONS

Per the Auditor General By-law, s. 3.14, the Auditor General reports directly to Council.

Pursuant to the *Vancouver Charter*, s. 161, the Auditor General Committee was appointed to, among other things, provide oversight to the Auditor General on behalf of Council.

Per the Auditor General By-law, s. 5.7, "...where the Auditor General considers a particular section of a policy does or might interfere with the Auditor General's ability to perform, in an independent manner, the functions assigned to the Office of Auditor General by this By-law, a submission on same must be made to the Auditor General Committee which will in turn submit its recommendations on the issue to Council for decision."

## REPORT

Following a review of the City's policies applicable to the Office of the Auditor General (OAG), and pursuant to s. 5.7 of the *Auditor General By-law*, the Auditor General proposes several changes to City policies which are described in Appendix A. The changes proposed in Items 1 through 4 in Appendix A are housekeeping in nature and are recommended as amendments to include the Auditor General in the appropriate policy sections. Items 5 and 6 of Appendix A relate to the City's Media Relations and Social Media Policies. It is recommended that the OAG be exempt from these media policies, and consequently any related obligation to be overseen

through City processes, due to the possibility of interference with the independence of the OAG. Since the OAG will release its own reports and deal directly with the media, replacement policies will be established for this purpose. These newly established media policies will be aligned with City Administration policies but will be independent and not hold the requirement of being overseen by city staff. Concurrence has been received by the City's administration for this recommended exemption and new media policies specific to the OAG.

### CONCLUSION

This report recommends housekeeping revisions to existing City policies and exemptions from the Media Relations and Social Media policies for the Auditor General Committee's endorsement and furtherance to Council for approval. These changes will further secure the OAG's ability to perform and function independently.
