


This slide shows the results of public consultation on an early draft of the Trout Lake Renewal plan. You can see the strong value the community places on having community garden. Despite this, later drafts of the Trout Lake Renewal Plan removed the community garden. In May, the Parks Board voted on a final Trout Lake Plan that did not include a garden. The week before the meeting, parks board received 170 messages in support of a community garden in the park. As a result, Parks Board has again directed staff to explore inclusion of community garden plots in the Renewal Plan. We are hopeful this will allow our garden to continue but it may be several years before anything materializes, if at all. I hope you can see how incredibly valued our garden is to the Cedar Cottage neighbourhood, and how important it is that we are able to continue community gardening effectively this year, and into the future.
