As experts on housing planning and policy, City Planning Staff and Councillors are no doubt aware that Vancouver has the tightest rental housing markets and one of the lowest vacancy rates in all of Canada; the rental vacancy rate is hovering somewhere around 1% today. With a steadily growing population, limited increases in income, rising inflation, and short supply of new, purpose-built rental housing in recent decades, the need for rental housing has and will continue to grow. This neighbourhood, in particular, is in need of more rental housing options, given that it's primarily single-family housing today, offering few options for renters in the area. The addition of 141 rental homes here will benefit the neighbourhood, local businesses, and will encourage more rental housing in the area. I applaud the City for thinking creatively about ways to allow enable gentle densification along arterials roads and in traditionally single family neighbourhoods, like this one, while still respecting the character of the area. While I am a strong supporter and advocate for below-market, non-profit run, publicly funded and owned, and co-operative housing - which we also need much more of in this city - as someone who rents in market housing in a neighbourhood with a diversity of housing and businesses, I also recognize that we need more purpose-built rental housing now, across the housing spectrum. You need to leverage all the tools at your disposal to help ease the intense pressure on renters. I hope this application will be supported at the Public Hearing on July 11th.
