Such housing also presents an opportunity for the private market to moderate, freeing capital for renters on the private market to save for their own home purchase, for starting a business, for emergencies, for retirement. It is abnormal and an obscene market failure to witness the average rent for a 1-bedroom to increase by 17% in one year (2022-2023). It is also important to articulate what is defined as affordable for those in the low-to-moderate income bracket, noting that the impact of such a decision also has succeeding consequences for when renters eventually exit the rental market and decide to purchase homes, in effect no longer constraining housing supply from interprovincial and external (outside of Canada) migrants entering Canada.</p> <p>Decisions by the federal, provincial, and municipal government to leave housing to the private sector and provide mortgage policy that has only fueled speculation has upset a realistic housing market, preventing even professional workers from planning for homeownership. I do not want this city to become one fueled only by the haves, without attention to the have nots. A society is best defined by how we're able to treat our most vulnerable, and our city has generally favoured NIMBY homeowners who are keen on solutions which don't affect the value of their property nor are in their area. What are the consequences when we look at housing solely as an investment vehicle as opposed to a right? What happens to even the children of NIMBYs who realise that they can only inherit their parents property(ies)? It is vital we build more housing (especially below market housing) in this city. We are in a crisis. Young people cannot afford to live in the city and raise families. The lowest income earners that fill vital roles in Vancouver cannot afford to live in the same city that they work in.</p> <p>This rezoning makes sense. The changes are good. 1050 Expo Boulevard is being changed from a parking lot that can house 0 people to a building with 296 units, 40% with enough room for families and 10% with enough room for a family of four. 990 Beatty Street is being changed from a vacant gravel lot that can house 0 people to a building with 288 units, space for a childcare facility (desperately needed), and a fire hall. Yes, I know some people don't want to live near a fire hall; they can feel free to move. Someone has to live near fire halls, the alternative is we just let fires burn down our city whenever they breakout (is Yaletown really better off without a firehall?). 450 Pacific Street is being changed from a utility shed to a medium building with 90 units, this is actually below the size of most buildings in the area and frankly could have been a bit more ambitious, but I'll take what I can get here.</p> <p>1050 Expo Boulevard and 990 Beatty Street are buildings who's height would be extremely similar to those around it. These buildings would not change the character of the neighborhood; they will match the existing character of the neighborhood. The additional units created by this rezoning will allow the city to reach its target for affordable housing in the area.</p> <p>I've seen a number of opponents suggest that this proposed rezoning would introduce crime and make the area less safe for children. With all due respect, I think these opponents need to read the proposal more carefully. These units would have lower-income thresholds of: annual household income of up to \$58,000 for a 1BR or studio, \$72,000 for 2BR, \$86,000 for 3BR. These are not units that are being built for homeless or destitute individuals. These units will not be introducing people with mental health issues and drug addiction to the neighborhood. The plan is for 661 solidly middle class income units with a substantial focus on units for families. Heck I'm a recently graduated engineer and I would qualify for this housing. This proposal will not make the area less safe for families, it will allow more families to exist in Vancouver rather than out in the suburbs. Proposals like this will help make our city more dynamic and prepared for the future with a growing population.</p> <p>I don't know about the individual members of the Council, but I think this proposal is a win-win for the city and the people that live in it.</p>	Adam S	Downtown
