#### TO: Vancouver City Council

- FROM: General Manager of Arts, Culture and Community Services
- SUBJECT: Housing and Homelessness Services 2024 Grants: Renter Services Grants and SRO Upgrading Grants

#### Recommendations

- A. THAT Council approve 14 Renter Services Grants totalling \$515,200 from the 2024 Housing and Homelessness Services Operating Budget ("EHT Allocation"), to the organizations listed in Appendix A of this report for the amounts recommended for each organization in the "2024 Recommend" column.
- B. THAT Council approve an SRO Upgrading Grant totaling \$60,000 from the 2024 Capital Budget – SRO<sup>1</sup> Upgrade Granting Program, to the Vancouver Tsung Tsin (Hakka) Association subject to:
  - i. All required development and building permits having been issued by the City; and
  - ii. The Vancouver Tsung Tsin (Hakka) Association entering into and registering on title to the property a Housing Agreement with a term of 3 years (until 2027) that will secure six rooms at 542 Keefer Street at rents no greater than the shelter component of income assistance (currently \$500 a single person), and otherwise upon such terms and conditions as the Director of Legal Services in consultation with the General Manager of Arts, Culture and Community Services may require.
- C. THAT Council approve an SRO Upgrading Grant totalling \$75,000 from the 2024 Capital Budget – SRO Upgrade Granting Program to the Downtown Eastside

SRO Collaborative Society (SRO-C), subject to a Grant Report containing terms and conditions outlined in this report, including reporting requirements.

- D. THAT Council allocate \$500,000 from the Empty Homes Tax Reserve for an additional year of the Renter Services Grants program for 2025 to enable non-profit organizations to provide critical programs and services to Vancouver renters at risk of displacement from their homes.
- E. THAT, pursuant to Section 206 (1) (j) of the *Vancouver Charter*, Council deems any organization that is to receive a grant pursuant to the above recommendations which is not a registered charity with Canada Revenue Agency, to be an organization contributing to the health and welfare of the City.
- F. THAT Council delegate its authority to execute grant agreements that include terms and conditions that are consistent with this report, that satisfy the City's Director of Legal Services, and that disburse the grants described in this report to the City's General Manager of Arts, Culture, and Community Services (or their designate).
- G. THAT no legal rights or obligations will arise or be created by Council's adoption of these Recommendations unless and until all legal documentation has been executed and delivered by the respective parties.

Approval of recommendations A, B and C require 2/3 affirmative votes of all Council members per section 206 (1) of the *Vancouver Charter*.

### **Purpose and Executive Summary**

This report seeks Council approval of 14 Renter Services Grants totalling \$515,200 to enable renter-serving non-profit organizations to provide critical programs and services to Vancouver renters, and two grants totalling \$135,000 to fund repairs and maintenance needs in SRO buildings.

It also recommended that Council allocate \$500,000 from the Empty Homes Tax Reserve to fund an additional year of the Renter Services Grant program for 2025.

#### **City Manager's Comments**

The City Manager concurs with the foregoing recommendations.

## **Context and Background**

#### Renter Services Grants

On June 12, 2019 (RTS 13180), Vancouver City Council formally approved funding to enhance non-profit advocacy and support services to Vancouver renters. Council approved the allocation of \$1.5 million over 3 years (2020-2022) from Empty Homes Tax (EHT) reserve, with \$500,000 to be allocated to each funding cycle. The Renter Services Grants program was subsequently created as a mechanism for disbursing this funding to non-profit partners.

On June 27, 2023 (RTS 15444), Council approved the continuation of Renter Services Grants for 2024 with \$500,000 to be allocated from Empty Homes Tax (EHT) reserve.

Funding through grants for renter serving organizations creates the opportunity for the City to work with community-based partners to better support and engage more renters in Vancouver. The funding can also encourage greater sector collaboration, proactive renter advocacy and research, and support long-term sector resilience.

- Over 2,200 Vancouver renters contacted organizations for assistance to pursue their rights and seek support services in navigating and maintaining their housing
- More than 300 youths impacted through renter services grants including support to search, secure, and/or maintain their housing
- Workshops were developed to empower and educate renters on their rights in different languages, including Arabic, Cantonese, Dari, Farsi, and Mandarin

# SRO Upgrading Grants

The SRO Upgrading Grant Program was first approved as part of the Downtown Eastside (DTES) Local Area Plan implementation in 2014. The grant program provides funding to non-profit housing operators to improve livability and life safety conditions of buildings designated under the SRA By-Law, while also securing affordability of rooms for low-income residents.

# Discussion

## 2024 Renter Services Grants (Recommendation A)

## Application, Review and Adjudication Processes

The 2024 Renter Service Grants information guide and application package were posted online in the early fall of 2023 prior to the application opening date. Email notifications with grant application information were sent to over 200 non-profit organizations in Vancouver. Where necessary, staff arranged additional meetings to answer questions and assist applicants.

Prior to adjudication, staff reviewed all applications to ensure they met eligibility requirements and conducted detailed reviews using grant program-specific criteria. The criteria was established in alignment with Council priorities, based on "good practice" for program and organizational management.

An adjudication team included staff from Homelessness Services, Affordable Housing, as well as Social Policy Grants.

## Evaluation and Investment Principles

In evaluating the grant applications, staff gave priority consideration to projects or services that met a range of principles and priorities, including:

- To fund a diversity of applications to ensure all goal areas are addressed (understanding rights, pursuing rights, retaining housing);
- To support projects whose primary focus is reducing conditions that create vulnerability for Vancouver renters;

- To consider equity and allocate funding so as to serve a range of equity-denied renter populations across the city;
- To consider the sustainability of the proposed project and the applicant's ability to expand capacity and leverage other investments and/or partnerships;
- To consider the level of innovation or enhancement to renter services; and
- To consider the overall quality of the proposal.

### Summary of Grants Recommended in this Report

This year, \$515,200 is available to allocate to organizations.<sup>2</sup> Staff received a total of 20 applications to the 2024 Renter Services Grants program, requesting a combined total of \$983,320.

This report recommends approval of 14 Renter Services Grants totalling \$515,200 (source of funds the 2024 Housing and Homelessness Services Operating Budget - EHT Allocation) See Table 1.

## Overview of Renter Services Grants Being Recommended

The 14 Renter Services Grants being recommended in this report encompass a range of services, programs and activities that support Vancouver renters. The grants aim to positively impact Vancouver renters in need of support or education, and support the needs of a diversity of low-income, equity-denied and at-risk renter populations across the city.

Activities supported by the grants include:

- Initiatives to empower and educate Vancouver renters, including seniors, women who are equity denied, individuals experiencing mental health challenges, and low income residents through a variety of approaches. This includes: info lines, online courses, and in-person programs.
- The pursuit of innovative solutions to increase the supply of wheelchair accessible rental housing in the City of Vancouver.

• The recruitment and training of volunteer lawyers and law students to appear before the Residential Tenancy Branch and the BC Supreme Court on behalf of Vancouver renters.

As the total amount of funding requested exceeded the budget, not all applications are able to be recommended for full funding. One application is being recommended for full funding and 13 applications are being recommended for partial funding. Appendix A summarizes the applications received and the recommended funding level of each. Appendix C summarizes applications not being recommended for funding.

#### SRO Upgrading Grants (Recommendations B and C)

Most SROs are over 100 years old and require significant investment and upkeep to remain operational and safe for residents, including addressing ongoing need for capital maintenance and upgrades. The two SRO Upgrading Grants being recommended in this report support the repairs and maintenance needs identified by SRO tenants and operators.

The \$60,000 grant to the Tsung Vancouver Tsung Tsin (Hakka) Association will fund repairs in washroom and shared kitchen/toilet areas in its six-unit building, improving building conditions and safety for the existing tenants. Through a Housing Agreement, the affordability of all six rooms will be secured at a maximum of shelter rate for a period of three years.

The \$75,000 grant to the DTES SRO Collaborative Society will support capital improvements in eight privately-owned SROs through expansion of its BOLTS (Building Operations Led by Tenants) program. BOLTS crew members assist their neighbours with minor repairs, cleaning and maintenance requests in order to maintain a better standard of living for all tenants in the buildings. The funding will be subject to a grant agreement which outlines specific terms and conditions, including reporting requirements related to how the funds are spent.

SRO Upgrading Grants are available on a rolling basis. Two applicants applied and both are being recommended for funding (see Appendix B). Staff reviewed both applications to ensure they met eligibility requirements and conducted detailed reviews using grant program-specific criteria.

#### **Financial Implications**

2024 Renter Services Grant

The total \$515,200 funding recommended in this report for 2024 Renter Services Grants is included in the 2024 Housing and Homelessness Services Operating Budget (EHT Allocation). This report recommends continuation of the Renter Services Grants in 2025 Grant budget and EHT funding to be included as part of the 2025 Operating budget process

The total \$135,000 funding recommended in this report for SRO Upgrading Grants is included in the 2024 Capital Budget – SRO Upgrade Granting Program. Monitoring, oversight, and future grant requests will be managed by the SRO-C and Supportive Housing team in ACCS.

The combined total of grant funds being recommended is therefore \$650,200 (Table 3). Grant funds will be disbursed by April 2024.

On June 12, 2019 (RTS 13180), Council approved the creation of funding for renter services to be allocated through grants or contracts to support non-profit renter-serving and advocacy organizations, allocating \$1.5 million to fund renter services and advocacy programs for three years from Empty Homes Tax reserve funds.

On November 28, 2017, Council approved the *Housing Vancouver Strategy* and *Housing Vancouver 3 Year Action Plan 2018-2020*. The 10-year *Housing Vancouver Strategy* is intended to foster a diverse and vibrant city, and is founded on the following:

1. Creating the 'Right Supply' of housing and addressing speculative demand

2. Protecting and retaining the existing rental stock

3. Supporting renters and vulnerable residents

The Strategy also embedded the SRO revitalization actions into a citywide framework to address housing affordability.

The current Council-approved goal is to replace SROs with self-contained, shelter-rate social housing for singles, with an accelerated replacement target of 2,000 new units over 10 years.

On March 12, 2014 (RTS 010175), Council adopted the Downtown Eastside Plan which identifies the need to replace 5,000 SRO rooms over the next 30 years with safe, secure and self-contained dwelling units on a one for one basis, while also upgrading the current stock in the interim.
