SUBJECT: Theatre Rental Grant Allocations – Fall 2024 and Spring 2025

#### Recommendations

- A. THAT Council approve Theatre Rental Grants totaling \$1,275,294 from the 2024 Cultural Grants Operating Budget to the 45 organizations listed in Table A of Appendix A for the amounts recommended in the "Sept 1 Dec 31, 2024 Recommendation" column to allow organizations to use the Civic Theatres for the September 1, 2024 December 31, 2024 season.
- B. THAT Council approve, in advance of the 2025 operating budget, Theatre Rental Grants totaling \$1,866,975 from the 2025 Cultural Grants Operating Budget to the 66 organizations listed in Table B of Appendix A for the amounts recommended in the "Jan 1- Aug 31, 2025, Recommendation" column to allow organizations to use the Civic Theatres for the January 1, 2025 August 31, 2025, season.
- C. THAT Council delegate its authority to execute grant agreements that include terms and conditions that are consistent with this report, that satisfy the City's Director of Legal Services, and that disburse the grants described in this report to the City's General Manager of Arts, Culture, and Community Services (or their designate).
- D. THAT, pursuant to Section 206(1)(j) of the *Vancouver Charter*, Council deems any organization listed in Appendix A of this report that is not otherwise a registered charity with Canada Revenue Agency to be contributing to the culture of Vancouver.

E. THAT no legal rights or obligations will arise or be created by Council's adoption of these Recommendations unless and until all legal documentation has been executed and delivered by the respective parties.

Recommendations A and B require two-thirds affirmative votes of all Council members pursuant to section 206 (1) of the Vancouver Charter.

### **Purpose and Executive Summary**

This report recommends a total of \$1,275,294 to 45 cultural organizations for use of the Vancouver Civic Theatres (VCT) during the Fall 2024 performing arts season that runs from September 1, 2024 to December 31, 2024.

This report recommends a total of \$1,866,975 to 66 cultural organizations for use of the Vancouver Civic Theatres (VCT) during the Spring 2025 performing arts season that runs from January 1, 2025 to August 31, 2025.

The recommendations support the key civic policy and strategic directions including Culture|Shift: Blanketing the City in Arts and Culture, the City's 10-year culture plan, including the Vancouver Music Strategy and Making Space for Arts and Culture.

## **Council Authority/Previous Decisions**

On May 30, 2023 (RTS 15583), Council approved 33 Theatre Rental Grants totalling \$1,349,795 for the period of Sept. 1-Dec. 31, 2023 and 57 Theatre Rental Grants totalling \$1,830,195 for the period of Jan 1-Aug. 31, 2024.

On November 28, 2023 (RTS 15719) Council approved new rental rates for VCT that included both commercial and not-for-profit rental rates for the performing arts season that runs from September 1, 2024 to August 31, 2025.

#### City Manager's Comments

The City Manager concurs with the foregoing recommendations.

#### Context and Background

The City of Vancouver has a long history of providing grants to local arts and culture non-profit organizations (NPOs). With that support, the City recognizes the role that arts and culture play in elevating the distinct characteristics of a city. This includes providing access to Vancouver Civic Theatres (VCT), one of the City's cultural assets, providing the NPOs with the opportunity to produce and present local and international artists and creators to residents and visitors of the City.

### VCT as a Department within the Arts Culture & Community (ACCS) Business Unit

VCT, one of Canada's preeminent theatre complexes, operates the Orpheum (2,672 seat concert hall), Queen Elizabeth Theatre (2,765 seat proscenium theatre), Vancouver Playhouse (668 seat proscenium theatre), and Annex (191 seat multi-purpose performing arts space) on behalf of the City. In 2023, VCT worked with commercial promoters, NPOs, and community groups, hosting 727 events in all four venues, with 750,024 patrons attending both public assembly and arts and cultural events representing a diverse range of disciplines, performing arts genres, and event types.

VCT enhances the performing arts experience and strengthens the cultural fabric of the City by hosting events that connect patrons and performers. Through state of the art professionally equipped theatres, supported by experienced professional staff, VCT plays an integral role in the cultural and economic health of the City. VCT provides culture enthusiasts with access to an endless array of arts and entertainment productions, including concerts, theatre, classical music, opera, dance, film, lectures and many other varied event types.

Many performing arts centres operate as NPOs and have access to multiple sources of funding (earned, public, and private). VCT, as a municipally owned and operated business, primarily relies on earned revenues from the following areas: venue rentals, VCT programming, food and beverage, facility fees, ticket surcharge, merchandise commission, and parking.

### About Theatre Rental Grants (TRG)

TRG are one of the few offset grants that support eligible cultural non-profit producers and presenters to access VCT's iconic, downtown civic venues and associated spaces. Grants to these organizations animate the City's theatres and present a range of culturally diverse performances for the enjoyment of citizens and visitors alike. This program is one of several programs, awards, and services that the City offers to support a diverse and thriving cultural ecology and a still recovering economy.

The TRG program is designed to support Vancouver-based, professional arts and cultural NPOs that have a mission to develop, create, produce, present, and disseminate artistic work for the benefit of the public and the arts sector, in any artistic discipline (e.g. Indigenous arts, community arts, dance, interdisciplinary, literary, media, multidisciplinary, music, theatre, and visual arts).

This offset grant program provides rental subsidy and assistance for certain VCT costs (including a portion of event staff labour costs and in-house technical equipment) and serves a range of organizations, from large-scale year-round users to small-sized occasional users. The program objectives are to assist organizations with artistic development, to increase their profile, and to expand their audiences.

If recommendations are approved, for the 2024/2025 TRG Season, VCT will provide access to a diverse range of programming in all disciplines, representing Indigenous, Latin American, South Asian, Asian, Middle Eastern cultures, and others.

#### **Discussion**

Recommendations in this report implement key directions of *Culture|Shift* and build on previous City support and investment in the cultural diversity and economic vitality of the city. The recommendations are for 2024/2025 Performing Arts Season that runs from September 1, 2024 to August 31, 2025.

### TRG Assessment Process

The applications were evaluated by a staff team from VCT and Arts & Culture, using the published application criteria, while also cross-checking applicants' bookings and theatre availability. The review considers the organization's capacity to produce the event as proposed, and the community impact of the presentation. Grants are being recommended to applicants as listed in Table A Section A (Sept. 1 – Dec. 31, 2024) and Table B (Jan. 1 – Aug. 31, 2025) of Appendix A.

TRG recommendations are awarded on a per usage basis and are equivalent to Councilapproved NPO rental rates.

Funds from any grants that cannot be partially or fully used are repurposed and reallocated to eligible but unfunded applicants or new initiatives that meet the TRG funding guidelines.

The recommendations are based on the published program criteria, which include:

- Equitable access to programs and services;
- Confirmed booking at a VCT venue within the 2024/2025 Season;
- Respectful and safe working conditions for artists, staff, volunteers, and contractors;
- Participation, Access and Impact (audiences and participants reflect the diversity of the city; accessibility plans and practices are in place; there is demand for the programs);
- Leadership and Administration (skilled leadership, working with artists and creative collaborators with the relevant lived experience, permission, knowledge, skills, and expertise to lead and contribute to the work); and,
- Have a mix of revenue sources (earned, private and public) for the project.

#### **Grant Recommendations**

TRG recommendations, as detailed in the financial implication section, for the 2024/2025 Season are as follows:

- For the 2024/2025 TRG Season, all applicants are being recommended for a grant.
- Year over year requested amounts consistently exceed available funding.
- For the 2024/2025 TRG Season, there were an additional 18 new and returning post pandemic eligible applicants compared to the previous Season (65 in 23/24 and 83 in 24/25).
- The 2024/2025 TRG Season saw an increased need in venue access for capacity and programming for equity-deserving non-profit organizations (NPOs)

- For the Fall 2024, staff are recommending funding 74% of overall requests, as available
  resources for TRG in 2024 are considerably less than in 2023; this percentage is more in
  line with that of previous seasons. In 2023 there was a large amount of unallocated TRG
  from prior years due to the effects of COVID-19 with most Fall 2023 applicants receiving
  100% of their request amount.
- For the Spring 2025, staff have recommended funding 71% of overall requests.

The TRG program works within established budgets to both make space for equity deserving and new and returning NPOs while at the same time continuing to support existing groups in their annual programming to provide access to VCT and support operational health.

#### **Financial Implications**

As an offset grant program, TRG is an internal transfer from the Arts & Culture Grants budget to the VCT Operating Budget. Council-approved TRG cover the costs of appropriate, approved, eligible event costs and are applied as rental revenue to the VCT Operating Budget. With this investment by Council, TRG events generate other revenue for VCT such as Food and Beverages sales, ticket surcharges, and parking. On average, TRG rental revenues represent approximately half of VCT's annual rental budget.

The 2024 TRG budget is \$2,953,731. In May 2023 (RTS 15583), Council approved in advance of the 2024 budget, grants totalling \$1,830,195 for Spring 2024 events at VCT venues. This Council approval now leaves \$1,123,536 to be allocated in the 2024 TRG budget. The post COVID-19 economic impact effected numerous granted organizations in 2023 with artists cancelling, visa challenges, organizational human resource challenges, and audiences slow return to public performance and as such forced some organizations to cancel or reduce the number of events or move to smaller capacity venues. In an effort retain these events at VCT, \$79,906 of un-allocated TRG has been carried forward to 2024 to maintain utilization of VCT. As of the April 30, 2024, 8 granted organizations have cancelled or will underuse their Spring 2024 approved bookings, thereby making \$72,225 available for reallocation in the Fall 2024 season. This will essentially fully utilize available funding for 2024, leaving a forecasted total of \$373 of TRG to be allocated at the end of 2024, as shown in Table 2.

Staff are therefore recommending 45 grants totalling \$1,275,294 for Sept. 1 - Dec. 31, 2024. The source of funds is the 2024 TRG budget.

This report also requests approval of grants to 65 organizations for VCT uses from Jan 1-Aug 31, 2025, totalling \$1,866,975 in advance of Council's confirmation of the 2025 operating budget. The source of funds is to be the 2025 Cultural Grants Operating budget. These grants are summarized in Table 3 and listed in Appendix A, Section B. Should the 2025 TRG budget remain the same as 2024 at \$2,953,731, a balance of \$1,086,756 in TRG funds will be allocated for the rest of the year.
