SUBJECT: 2024 Cultural Grants (CASC, Capacity, Cultural Spaces)

Recommendations

- A. THAT Council approve Communities and Artists Shifting Culture (CASC) grants totalling \$520,000 from the 2024 Cultural Grants Operating Budget to the 72 organizations listed in Appendix A for the amounts recommended for each organization in the "Recomm" column.
- B. THAT Council approve Cultural Learning and Sharing (CLS) grants totalling \$100,920 to the 14 cultural organizations listed in Appendix B for the amounts recommended for each organization in the "Recomm." column.
- C. THAT Council approve 10 Cultural Infrastructure Grants and 27 Small Grants for Cultural Spaces totalling \$1,416,500 from the 2024 Cultural Spaces Capital Budget (\$1,146,500), the 2024 Chinatown Cultural Partnership Program Capital Budget (\$250,000), and the 2024 Capital Budget for New Public Art (\$20,000) to the organizations listed in the tables titled "Cultural Infrastructure Grant", "Cultural Infrastructure Grant Chinatown Cultural Partnerships", "Cultural Small Grant", and "Cultural Small Grant Public Art" in Appendix C for the amounts in the "Recomm" column.
- D. THAT Council approve 18 Affordable Spaces Grants totalling \$305,000 from the 2024 Cultural Grants Operating Budget to the cultural organizations listed in the table titled "Cultural Affordable Spaces Grant" in Appendix C for the amounts recommended for each organization in the "Recomm" column.
- E. THAT Council approve a Making Space for Arts and Culture priority grant of \$1,500,000 from the Vancouver Cultural Spaces Fund to the Dance Foundation to procure the Vancouver Dance Centre site as described in the table titled "Cultural Infrastructure Grant Making Space for Arts and Culture Priority" in Appendix C.

- F. THAT, subject to the approval of Recommendation E, Council approve an increase to the 2023-2026 Capital Plan and the Multi-Year Capital Project Budget for the Cultural Spaces Grants program by \$1,500,000, to be funded from the Vancouver Cultural Spaces Fund. 2024 Annual Capital Expenditures will be managed within the existing Citywide 2024 Annual Capital Expenditure Budget.
- G. THAT Council authorize the Director of Real Estate Services to negotiate and execute extension agreements for terms of up to three years for the six lease or sublease agreements (collectively, the "Leases") under the Artist Studio Award program with the tenants (collectively, the "Tenants", and each a "Tenant") of City-owned or City-leased artist studios (collectively, the "Premises", and each a "Studio") as detailed in Appendix D, with each extension in a form satisfactory to the Director of Legal Services and in consultation with the Deputy General Manager of Arts, Culture and Tourism.
- H. THAT Council approve the re-tenanting of any Studio that becomes vacant for an extended period during the occupancy term to another eligible artist approved by the Deputy General Manager of Arts, Culture and Tourism on the same terms and conditions as the original artist Tenant of the Studio.
- I. THAT Council delegate its authority to execute grant agreements that include terms and conditions that are consistent with this report, that satisfy the City's Director of Legal Services, and that disburse the grants described in this report to the City's General Manager of Arts, Culture, and Community Services (or their designate).
- J. THAT pursuant to Section 206(1)(j) of the *Vancouver Charter*, Council deems any organization that is to receive a grant pursuant to the above Recommendations and that is not otherwise a registered charity with the Canada Revenue Agency to be contributing to the culture of the city.
- K. THAT no legal rights or obligations will arise or be created by Council's adoption of these Recommendations unless and until all legal documentation has been executed and delivered by the respective parties.

Recommendations A, B, C, D, E require two-thirds affirmative votes of all Council members under section 206 (1) of the Vancouver Charter.

As the rent under the Leases for the Premises will be below the applicable market rate and includes rent-in-lieu of property taxes, Recommendation G constitutes a grant valued at approximately \$185,000 per annum based on the first year of the term of the Leases, and requires not less than two-thirds of an affirmative vote of all Council members per Section 206 (1)(j) of the Vancouver Charter

Purpose and Executive Summary

This report recommends a total of \$3,842,420 to 142 arts and cultural organizations. It also provides a report back on a previously disbursed total of \$66,508 to seven (7) cultural spaces through critical assistance grants. Lastly, the report recommends that Council authorize lease extensions of up to three years for the remaining six Tenants in Vancouver's Artist Studio Award Program spaces.

The recommendations support the following relevant civic policy and strategic directions:

- Culture|Shift and Making Space for Arts and Culture
- The City's Reconciliation Framework, and UNDRIP Strategy
- The City's Equity Framework, and Accessibility Strategy
- Chinatown Cultural Heritage Assets Management Plan (CHAMP) Strategic Framework

Council Authority/Previous Decisions

On September 10, 2019, Council adopted Vancouver's 10-year culture plan <u>Culture|Shift:</u> <u>Blanketing the City in Arts and Culture</u> including <u>Making Space for Arts and Culture</u>, and the Vancouver Music Strategy.

On November 16, 2021, Council approved (RTS 14658) nominal leases for seven artists for three-year terms for the work and live/work spaces that are part of the City of Vancouver's Artist Studio Award Program.

On July 25, 2023 (RTS 15658), Council approved the <u>2024 Arts and Culture Grants Program Framework</u> outlining policy alignment, programs, adjudication process, budget, and accountability requirements for Arts and Culture granting.

City Manager's Comments

The City Manager concurs with the foregoing recommendations.

Context and Background

The City of Vancouver supports the arts and culture sector through operating and capital grants to local arts and culture non-profit groups through various grant streams, including operations, projects, capacity-building, cultural spaces, and access to the civic theatres. The City's continued investment acknowledges the significant contribution of the creativity and resilience of artists, cultural workers, and organizations to a culturally vibrant community and local economy.

Discussion

Recommendations in this report include project-based grant programs, and cultural spaces capital and operating grants that support the local arts and cultural community. In line with best practices applied by funders across Canada, grant applications are assessed on an annual basis by a community peer assessment committee. These grants provide vital support for the creation, development and production of artistic work, cultural infrastructure projects, and support critical programs and services to culturally-specific communities, artists, and the public. The recommendations also support affordable studio spaces for six local artists.

Grant Recommendations

Recommendation A: Communities and Artists Shifting Culture (CASC) Grants - \$520,000 to 72 organizations (Appendix A)

Communities and Artists Shifting Culture (CASC) is a key grant program for project-based funding in Vancouver's arts and culture sector. CASC is often the first opportunity for new groups to receive support; many recurring arts-based events and activities that comprise Vancouver's rich cultural fabric are regular funding recipients. Grants of up to \$15,000 are available and there are two intakes each year.

CASC is open to non-profit groups offering arts and culture programming and advances the goals of *Culture*|*Shift* by increasing the representation of equity-deserving applicants to Arts, Culture and Tourism (ACT) funding programs. The support of artist-centred and artist-led programs is a central value of the CASC program; individual equity-deserving artists and collectives are able to apply in partnership with non-profit organizations.

CASC is assessed by committees comprised of community and staff. Committee members bring a wide range of lived and professional experience in multiple disciplines and with various communities, and provide intersectional, artistic and administrative perspectives and expertise to the process. Committee members for this intake of CASC, the second of 2024, were Jules André-Brown, Kaya Kurz, Anjela Magpantay, Maurice Nahanee, Jarin Schexnider, and Sophia Wolfe. All committee members completed conflict of interest forms and removed themselves from discussion and decision-making if conflicts were declared. Staff sincerely thank all peer community members for their thoughtful consideration and generosity throughout the assessment process.

In this report, 72 of 109 applications are recommended for funding; the requests are \$1,392,425 and recommended grants are \$520,000. Approval of these grants will support hundreds of artists from equity-deserving communities and many creative projects, festivals and celebrations that make Vancouver a thriving, vibrant place to live. As requests typically exceed available funding, not all projects can be recommended. Program metrics are at the end of Appendix A. Recommendation B: Cultural Learning and Sharing (CLS) Grants - \$100,920 to 14 organizations (Appendix B)

Cultural Learning and Sharing (CLS) grants provide up to \$20,000 to non-profit arts and cultural organizations to access or deliver learning opportunities that will build and strengthen skills, knowledge, relationships, and experience to enhance organizational, sectoral or individual arts and leadership practices. The program prioritizes artists and cultural leaders who identify as Indigenous, Black or of African descent, People of Colour, Deaf/deaf, Hard of Hearing, living with a disability/disabled people, LGBTQ2+ and gender diverse or artist and cultural organizations and leaders that wish to build pathways to becoming more equitable.

In this report, 14 of 23 CLS applications are recommended for funding; the requests are \$354,818 and recommended grants are \$100,920. The non-profit organizations in this report were submitted for review at the second of three intake dates for CLS in 2024. With a 171% rate of increase in applications in 2024 since 2022, the first two intakes were larger than prior years and the annual program funds have been depleted, and a third cut off date in September 2024

Recommendations C, D, E, G, Cultural Spaces (Appendix C)

Vancouver continues to experience significant loss of affordable places for artists to live, work, and share their work. Cultural Spaces Grants advance Council's ten-year cultural spaces plan, *Making Space for Arts and Culture* to support access to affordable cultural spaces and to strengthen:

- x^wməθk^wəy əm, Skwxwú7mesh, səlilwətał and urban Indigenous self-determined cultural spaces, cultural redress, equity, diversity and accessibility
- a robust and diverse ecology of cultural spaces; including increasing community owned and operated cultural spaces
- greening upgrades and sustainability

Capital grants, recommendations C and E, are reviewed by staff, professionals such as architects and community representatives (community representatives were Kristin Cheung, Jonathan Ryder, Lili Vieira de Carvalho, and David Scott). Affordable Spaces, as a relatively new program, is reviewed by staff with a focus on eligibility and need. Recommendation C Cultural Infrastructure Grants (capital) - \$749,500 to 8 Organizations Up to \$250,000 for non-profit arts and cultural organizations to plan, research, buy, repair, renovate and improve Vancouver's cultural spaces with the goal of strengthening the arts and culture community's ability to develop, and sustainably operate, affordable space.

- 9 submissions requesting \$1,449,217
- Staff recommend 8 grants totalling \$749,500
- 33% of submissions from non-profits operating City-owned spaces; 67% from non-profits operating in private or community owned spaces

Recommendation C Small Grants for Cultural Spaces (capital) - \$417,000 to 27 Organizations Up to \$25,000 to non-profit organizations to support timely space-related capital projects including planning, research, accessibility upgrades, and/or mentorships. Special consideration given to organizations, communities or areas of practice underrepresented in existing support or facing significant barriers.

- 36 submissions requesting \$753,233, 25% of submissions were first-time applicants
- Staff recommend 26 cultural spaces grants totalling \$397,000
- Staff recommend a public art grant of \$20,000 for a ceiling feature highlighting local First Nation's weaving design in two FLEET mobile artist studios
- 9 recommended projects for space planning; 1 space mentorship; 1 public art, and 16 for small capital improvements

Recommendation C: Chinatown Cultural Partnerships Grants – \$250,000 to two organizations The Chinatown Cultural Partnership funding provides additional support to cultural spaces in Chinatown. Staff recommend:

BCA Society - Upgrades to increase artist studios spaces at Sun Wah building

- Wongs' Benevolent Association Improvements to vacant space in the Hon Hsing building, which supports activities such as the Lion and Dragon dance and Chinese classical music
- Staff will continue to support applicants not recommended in this report, in future funding opportunities

Recommendation D: Affordable Spaces Grants (operating) - \$305,000 to 18 Organizations

An operational grant stream providing up to \$40,000 towards facility operating costs to support non-profit space operators who provide subsidized affordable space for professional artists and cultural organizations. Funds are prioritized to support retention of cultural spaces that provide space for multiple artists and/or organizations, space operators who are not typically funded through existing grant programs, and cultural communities who are most at risk of being displaced.

- 19 submissions received requesting \$574,000
- Staff recommend 18 grants totalling \$305,000
- Supporting 135,322 square feet of cultural space for over 1,183 artists

Recommendation E: Making Space for Arts and Culture Extraordinary Grant Requests

The Dance Foundation

The Dance Foundation is the owner of Scotiabank Dance Centre (the Dance Centre) at the corner of Davie and Granville Street. The Dance Centre, opened in 2001, is an important, unique and exceptional purpose-built, shared use dance hub on Granville Street. It is one of a few of non-profit owned and run cultural spaces in Vancouver. The 32,000 square foot, purpose-built dance centre, includes four rehearsal spaces, and a 200-seat black box theatre. The Dance Centre hosts rehearsals, residencies, classes, performances, and events, with 87,000 visits annually, and providing affordable rentals to over 250 artists.

The building is on land owned by Scotiabank, entrusted to the Foundation under a long-term lease expiring in 2029. The owner has indicated it will not extend the land lease and has provided to the Foundation an offer to purchase the land at a set price that expires in September this year. The Foundation is working to raise funds to procure the land through private and public fundraising. Ideally, the owner will consider the original intent of the project and contemplate a significant donation. Staff are concurrently working on the Granville Street Planning process and seeking ways to secure retention of critical cultural spaces such as the Dance Centre, as part of that plan.

Staff recommend an extraordinary grant of \$1.5M to support the Dance Foundation in securing and procuring the site, conditional on securing the required funding, review and confirmation of the sale (for example funds would be disbursed in trust as part of sale), and an addition of community use agreement on title ensuring the use of the site as a non-profit dance centre, providing affordable spaces for artists and production and administration space for local non-profit dance organizations for the benefit of the citizens of Vancouver in perpetuity. Should a donation be secured from the current landowner, the grant would not be disbursed and there would be no financial impact for the City. The Foundation will continue to operate and maintain the Dance Centre.

The Firehall Theatre

The Firehall Theatre Society submitted an extraordinary request for support for the critical renewal of the City-owned Firehall Theatre in the DTES. At the forefront of disability, equity and Indigenous programming since inception 40 years ago, the building has no physical accessibility in most of the building, does not meet basic Canadian Actor's Equity standards and has been in urgent need of renewal for over a decade. Given that the renewal of the building is a City responsibility, funding to complete the project is under review as part of the mid-term capital update. Staff are providing this request as information for Council only. The community reviewers were very supportive of the request (see Appendix E for more details).

2023/24 Critical Assistance for Cultural Spaces Report Out Only (Appendix C)

This capital grant stream provides up to \$25,000 towards repairs or upgrade costs to non-profit cultural spaces facing critical situations including facility life-safety issues to ensure access to safe, legal, and fully functioning cultural spaces. Staff review requests and are authorized by Council to allocate these grants throughout the year. In 2023/24 7 grants totalling \$66,508 have been disbursed under this authorization.

Recommendations G - 6 Artist Studio Award Program Leases (Appendix D)

Since 1995, the Artist Studio Award Program has awarded studios at below-market rates to professional Vancouver-based artists recognized by their peers and eligible for affordable housing, working in any artistic discipline for terms of approximately three years. This program aims to reduce financial barriers for artists and supports the development of their cultural and art practice at a critical point in their career.

In 2021, Council approved (RTS 14658) leases for the 2022 to 2025 term and the studios were dedicated to professional Vancouver-based artists who are Indigenous and/or racialized with a priority for eligible Musqueam, Squamish, and Tsleil-Waututh artists. Staff are recommending extending the six leases (four live/work and two work only) up to three years for the current cohort, to provide time to review and improve the current program, to access and plan for any required renewal and improvements required for the studios (some of which are almost 30 years old), as well as to provide stability for the existing tenants. The value of the studio spaces and in-kind grant is estimated at \$185,000 per year.

Financial Implications

The sources of funding for these recommendations are the 2024 Cultural Grants Operating & Capital Budget as summarized in Table 1.

CASC supports three categories of activities: artistic creation/production; festivals, arts components of celebrations and parades; and community-engaged arts practice. Included in these categories are projects from all artistic disciplines, in various stages of development, that take place in neighbourhoods across Vancouver.


The notes below highlight some relevant data about CASC second intake grants:

- 109 applicants, 72 recommended grants by three assessment committees.
- Total funding requested: \$1,392,425; total funding recommended: \$520,000.
- Average recommended grant: \$7,289; highest grant: \$14,000; lowest grant: \$2,500; median grant: \$7,000; and most common grant: \$6,000.
- First-time applicants had a 38% success rate (five of 13 recommended for funding).
- Sponsored artists or artist collectives had a very strong (83%) success rate (15 of 18 applicants recommended for funding).
- The majority of recommended applications are for performing arts: music, dance, theatre (40%); visual arts, film, and digital media (15%); community arts/social practice (11%); multidisciplinary/interdisciplinary (11%); and cultural heritage (9%) projects.

Common reasons for not recommending a grant include:

- Less demonstrated need for additional public sector support compared to other groups
- Insufficient alignment of project with program goals and criteria
- Lack of key information to understand artistic and community impact
- Limited information on financial and human resources to ensure the successful realization of the project


The chart below shows Vancouver's neighbourhoods that will be served if the grant recommendations are approved. Some projects serve multiple neighbourhoods.

APPENDIX E

Making Space for Arts and Culture Extraordinary Request Firehall Theatre Capital Renewal and Accessibility

The 40 year-old Firehall Theatre is a 12,000 square foot performing arts centre with a 140 seat theatre, rehearsal space, community offices, lobby, box office located in the DTES in a City owned 117 year brick building. The non-profit has been at the forefront of disability, equity and Indigenous programming – using the building approximately 300 days per year with 200-250 performances, supporting more than 100 artists and welcoming audiences of 35,000 people.

The building has been in urgent need of renewal for over a decade. There have been on-going public complaints on accessibility, the state of building and end of life systems (electrical, HVAC, roof). Wheelchair performers can only access building through long narrow side entrance to the stage and can not access the subpar bathroom during a performance. There is no wheelchair access to the rest of the building which includes the main entrance, box office, lobby, bar, offices, rehearsal, green room, dressing rooms (that do not meet Canadian Actor Equity Standards).

The Firehall Theatre Society submitted an extraordinary request for the critical renewal and upgrade of the City-owned theatre to create physical accessibility for audiences, artists and staff by installing an elevator, ramps, building adequate accessible washrooms and industry standard dressing rooms, and associated seismic upgrades. The total project is estimated at \$23M and includes upgrades to accessibility to the adjacent Police Museum. A second option is a 9.3M project focusing on the Theatre. Given that the renewal of the building is a City responsibility, funding to complete the project is under review as part of the mid-term capital update. Staff are providing this request as information for Council only. The community reviewers were very supportive of the request however the grant budget has limited funds available and the mid-term capital update is the appropriate place for this need to be considered.
