Large developers are increasingly constructing what they term "affordable units" for sale, often to benefit from incentives such as increased building capacity, allowing for more floors. However, the prices of these socalled "affordable units" remain out of reach for many people, including those earning \$100,000 per year. This is especially the case for family size dwellings. This problem is particularly noticeable in neighbourhoods like Strathcona and Marpole (where I live), where the availability of affordable rental units is declining as new developments emerge with high price tags. As similar pressures mount in other neighbourhoods, the overall strain on Vancouver increases, making it more difficult to preserve affordable housing options for residents. Social housing has been proven to work as an effective solution for Vancouver's housing crisis. Social housing family units create diversity and sustainability in communities of Vancouver. E.g. essential workers of Vancouver cannot afford to live in Vancouver.
