And it was the speakers that were here; speakers from Team for a Livable Vancouver - who actually care about the city and the people in it, who care about their constituents - and speakers from people who live and thrive and call these amazing neighborhood's homes; speaking out, giving us the information and the ACTUAL TRUTH.

And I was shocked. And sickened. I still am.

And all the people around me were shocked and sickened. They all still are.

We did not know that The City plans to scorch earth three neighbourhoods and cover them with unlimited amounts of high-rise towers, at unlimited heights, with unlimited densification.

It still feels like a nightmare and I'm waiting for us to wake up and for this to be just that - a nightmare; and then we wake up and common sense is still here and our beautiful city is still here and not under threat.

But it's not a sleeping nightmare.

It is an actual, living nightmare; this is actually happening.

And we need to stop it from happening.

We need to pause the Broadway Plan.

We need to copiously go through every part of the Broadway Plan in absolute detail, and revise it;

with WE, THE PEOPLE, the residents, the citizens of Vancouver,

and the architects, developers, and builders who have worked on previous Vancouver City projects, and with such success and in keeping with the beauty and history of Vancouver – **not student developers who have no ties to our beautiful city so have no care for it and its people.** 

And this is why I am opposing this rezoning proposal of 1171 W. 12<sup>th</sup> Avenue.

And why I oppose the Broadway plan.

And why I oppose the pro-density, pro-demoviction, pro-wealthy, ABC party.

Stop destroying Vancouver neighborhoods.

Stop destroying Vancouver communities.

Stop destroying Vancouver.

Also, stop making it even harder and harder for people with disabilities to be able to remain in the Hospital Zone area for their healthcare and life support needs.
