I could be misunderstanding the rendering/pitch but I just want to state that walkability through the site would greatly help ensure that the development feels like it's a 'joining with' the neighbourhood as opposed to bulldozed through. I urge council and staff to seriously consider ways to reduce the negative impact so we can collectively reap more of the benefits of densification (than the downsides).
