I'm aware of the need to densify the city in order to accommodate the current and future housing needs of the city and feel that it can be done in a way that makes all parties happy. The Rezoning Application booklet states "The residential site is located in the Kitsilano community, the neighbourhood voted as "Vancouver's Best Neighbourhood" more than five years-running by the readers of the Georgia Straight, as well as "Neighbourhood That Best Represents Vancouver" in the West Ender Newspaper, and "Best Shopping Neighbourhood" by the Vancouver Courier."  This is a unique and community minded Kitsilano neighbourhood with a quiet charm to it, with all the restaurants, coffeeshops, and businesses on West 1st Ave. I'm concerned that the height of the proposed building on West 2nd will tower over the area and take away some of this 'unique charm' the area has. I looked at the 'Shadowing" studies, and I think West 1st will be cast under the building's shadow to a larger degree than what those studies are showing. The businesses and coffeeshops on West 1st will lose most of the early/mid morning sun in spring and fall and to a lesser degree in summer. It will definitely cast its pall over the neighbourhood. I think even if the building was only 15 stories instead of 20, would make it less overbearing to the neighbourhood.  Something that may not be currently considered is the busyness of the alley between West 1st and West 2nd Avenues. With Cypress Street being a 1 way street between West 1st and West 2nd, a lot of busy traffic is routed to our alley, often with drivers driving at a high speed. With possibly 61 parking stalls in the new building, it's going to make the alley even busier. This is an important safety concern that needs to be considered and I hope there are plans to build some speed bumps into the alley.
