## Amendments | Overview

Proposed amendments to modernize business regulations

- Land Use By-laws (ZDBL & DODP)
  - Expand potential locations for Arcade, Adult Retail Store & Restaurant – Class 2
  - Update definition for Arcade

- 2 Licence By-law
  - Remove restrictions on age of entry and hours of operation, specifically for Arcade and Adult Retail Store

 Regulations introduced in 1989 to address issues around school absenteeism, youth loitering, and delinquency



• Permitted in a limited number of commercial zones

• Defined as a premises that has 4 or more arcade machines

#### ZDBL / DODP Amendments

• **Allow** Arcade as a use in all commercial zones

#### Arcade

• **Update** Arcade Use definition to:




• **Remove** number of machines that require a business to be considered an Arcade use

• **Include** virtual reality rooms

#### Licence By-law Amendments

#### Arcade



#### Remove:

• Age of entry restrictions

Limits on business hours

Requirement to post patron rules of conduct

#### Overview

Introduced as a conditional use in 1994

#### Adult Retail Store

Permitted in limited zones with restrictions



Subject to DP renewal

#### ZDBL / DODP Amendments

Adult Retail Store



#### **Remove:**

 Adult Retail Store use and allow stores selling adult goods as the Retail Store use

- Section 11 regulations:
  - Development permit renewal
  - Restrictions on co-location with arcades
  - Limits to store size and frontage

Repeal: Adult Retail Store Guidelines

# Adult Retail Store



#### **Remove:**

Adult Retail Store as a business licence type


Restrictions on age of entry and hours of operation

Regulations on indoor display of adult publications

**Retain** restrictions on the display of adult goods in store windows

#### Overview

#### Restaurant Class 2





 Restaurant - Class 2 is permitted in many commercial or mixed-use zones, but not all

Restaurants with liquor service are required to obtain
Provincial (LCRB) patron participation endorsement

#### ZDBL / DODP Amendments

#### Restaurant Class 2




 Expand Restaurant – Class 2 to areas of the city where Neighbourhood Public House and Cabaret are permitted (also allow patron participation)
