SUBJECT: 2026 Engineering Fees

Recommendations

- A. THAT Council approve in principle a 4.5% increase in the Engineering Services Department permit, application and licence agreement fees as set out in Appendix A to this report to take effect on January 1, 2026, with the exception of the fees referenced in Recommendations B, C, D, E, and F.
- B. THAT Council approve in principle a \$23 to \$55 increase for certain resident parking permit fees under the Street and Traffic By-law No. 2849, with the exception of section 23.4 (b), as set out in Appendix A to this report, to take effect on January 1, 2026.
- C. THAT Council approve in principle an increase to special event market fees under the Street Vending By-law No. 10868, as set out in Appendix A to this report, to take effect on January 1, 2026.
- D. THAT Council approve in principle increases to electric vehicle charging fees under the Parking Meter By-law No. 2952, as set out in Appendix A to this report, to take effect on January 1, 2026 and April 1, 2026.
- E. THAT Council approve in principle a 6% increase in addition to a 4.5% inflationary increase to patio permit fees for large sidewalk patios and curbside patios, and elimination of application and permit fees for small sidewalk patios, under the Street Vending Bylaw 10868, as set out in Appendix A to this report, to take effect on January 1, 2026.

- F. THAT Council approve in principle a 6% increase to permanent street restoration charges under Part 3 of the Street Utilities By-law No. 10361, as set out in Appendix A to this report, to take effect on January 1, 2026.
- G. THAT Council approve in principle a 50% increase in Waste Container License Fees to \$1,162.38 for containers greater than 1 cubic yard and \$387.45 for containers less than 1 cubic yard, as set out in Appendix A to this report.
- H. THAT Council approve in principle a \$13 to \$50 increase to the fines for certain by-law offences under the Street and Traffic By-law No. 2849, as well as consequential amendments to the By-law Notice Enforcement By-law and the Ticket Offences By-law, as set out in Appendix A to this report, to take effect on January 1, 2026.
- I. THAT Council approve in principle a 10% decrease in the discount amount for all fines for by-law offences under the Street and Traffic By-law set out in the By-law Notice Enforcement By-law, to take effect on January 1, 2026.
- J. THAT Council approve in principle a decrease in the fine for the offence of failing to remove snow within 24 hours under the Street and Traffic By-law No. 2849 to \$499.00, as well as a consequential amendment to the Ticket Offences By-law, as set out in Appendix A to this report.
- K. THAT the Director of Legal Services be instructed to prepare by-laws to amend Street and Traffic By-law No. 2849, Parking Meter By-law No. 2952, Granville Mall By-law No. 9978, Encroachment By-law No. 4243, Street Vending By-law No. 10868, Street Distribution of Publications By-law No. 9350, Street Utilities By-law No. 10361, Crossing By-law No. 4644, By-law Notice Enforcement by-law No. 10201, and Ticket Offences By-law No. 9360, all generally in accordance with Appendix B.

Purpose and Executive Summary

Engineering fees are adjusted on an annual basis to reflect cost increases. For 2026, the 4.5% cost escalation is driven in part by collective agreement patterns regionally and nationally. The City's cost of delivering existing services is also impacted by higher cost increases in non-salary including:

- 1) increases in fixed costs such as building costs, utilities, leases, insurance; and
- 2) construction inflation continues to impact the City's cost base, with higher costs for maintenance of City's assets.

The proposed increases and rationales for the exceptional adjustments listed in Recommendations B, C, D, E, F, G, H, and I are set out below.

Council Authority/Previous Decisions

Council has historically set fees with the overall objective of recovering the full cost of providing the associated services or, where there is a market-based justification, maintain competitiveness with comparators.

City Manager's Comments

The City Manager concurs with the foregoing recommendations.

Context and Background

The Engineering Services Department generates revenues from several sources under the authority of the following by-laws:

- Street and Traffic By-law No. 2849,
- Parking Meter By-law No. 2952,
- Granville Mall By-law No. 9978,
- Encroachment By-law No. 4243,
- Street Vending By-law No. 10868,
- Ticket Offences By-law No. 9360,
- Street Distribution of Publications By-law No. 9350; and,
- Street Utilities By-law No. 10361.

The fees indicated under these By-laws were last adjusted effective January 1, 2025.

Discussion

Fees are set at a level which reflects the City's cost's structure and are typically adjusted annually to keep pace with costs. Recommendation A considers a 4.5% increase to fees, which is consistent with expected growth in the City's direct and indirect costs to deliver services.

This 4.5% increase has been applied to all the fees listed in Appendix A, with the exception of the exceptional fee adjustments noted below:

Residential Parking Permit Fees

Resident permit parking in the City is generally located in areas of high parking demand. Existing parking permit costs are significantly less expensive than the cost of surrounding off-street parking and are low relative to many other major centres. Staff recommend increasing permit fees at a higher rate than inflation to better manage demand and recognize the value of on-street parking, except for the market rates in the West End which are proposed to increase

by 4.5%.

Street and Traffic By-law Fines

Street and Traffic By-law fines generally apply when the owner of a vehicle parks their vehicle in a location that is not permitted for parking or does not pay for parking at a metered parking space, as well as in other circumstances as described in the respective bylaw. The increases in by-law fines, and reduction of discount percentages for early payment, are aimed to improve compliance, safety outcomes, and the flow of traffic in the city.

Special Event Market Fees

Over the past two years, the volume of special event markets—particularly those with a commercial focus—has increased substantially. This increase has placed added pressure on public spaces, many of which are also used for free community events and cultural programming. A fee structure can help support balanced and sustainable management of these spaces. These fees are intended to recover the administrative and operational costs associated with permitting, coordination, and oversight of markets and special events. The structure will reflect the value of each location, applying a sliding scale based on factors such as whether the market is held in the downtown core versus other areas, and the prominence or visibility of the site. Fees will range from \$200 to \$2500 per day. This approach promotes equitable access by balancing the needs of revenue-generating events with those of free special events.

Electric Vehicle Charging Fees

The City endeavours to charge the same fees as BC Hydro for electric vehicle (EV) charging. Currently the City charges less than BC Hydro, so the proposed fee changes will match <u>current BC Hydro fees</u>, starting on Jan 1, 2026. BC Hydro's fees will change on <u>April 1, 2026</u>, so it is proposed that the City's EV charging fees be updated again at that time to align with the future BC Hydro EV charging fees. The proposed changes are described below.

Patio Permit Fees

Revenues from the Patio Program currently do not cover the City's costs to manage the program nor account for the value of commercial use of the street right-of way. To achieve cost recovery, staff recommend increasing permit fees by 6% per year for 3 years in addition to the annual inflationary increase, after which permit fees would normalize. Staff further recommend that application and permit fees for the "small patio" program be eliminated, as the proposed program updates include changing this patio type to a no-fee, permit light option, renamed "storefront seating". A full rationale for adjustments to patio fees are outlined in the Patio Program Updates Council Report (scheduled for Nov. 26, 2026).

Permanent Street Restoration Costs

An analysis comparing internal and external construction costs to the City's permanent street restoration rates has been completed. The increase in permanent restoration costs reflects the rising expenses associated with repair work. The primary areas where expenses have increased include supplies and services such as concrete and asphalt. Permanent street restoration fees are charged to utility companies for restorations necessitated by utility installations, maintenance, or repairs. In most cases, utility companies can opt out of paying restoration fees by completing repairs themselves

Fine for Failure to Clear Snow

The secondary fine amount for failure to clear snow and ice within 24 hours was introduced in June 2021 as a tool to encourage greater compliance with sidewalk snow and ice removal requirements. Since then, the program has evolved to include pedestrian-priority sidewalk routes and transitioned enforcement to the Parking Enforcement platform, aligning with practices used for water restriction violations. While the cost of program delivery has decreased, the higher fine has not resulted in a measurable improvement in compliance. As such, the fine is being reduced to support more effective enforcement and better alignment with regional ticketing practices. Multiple tickets remain an available enforcement option for properties demonstrating significant non-compliance.

Waste Containers stored on public property

The City maintains Container License Agreements (CLAs) with approximately 15 commercial waste haulers who store garbage, recycling, and organics containers on public streets and laneways. These agreements regulate container placement and include licensing fees to recover program administration costs, which cover oversight by inspectors, support staff, and supervisors.

Currently about 2,000 licensed containers of varying sizes are stored on public property across Vancouver. While essential for waste management, these containers often attract illegal dumping, vandalism, litter, and disorder—particularly in laneways—prompting increased demand for abandoned waste collection, flushing, sweeping, and micro-cleaning.

To address these pressures and support cleaner, safer public spaces, staff recommend a 50% increase in licensing fees in 2026. This adjustment aims to:

- Reflect inflation and rising operational costs tied to Sanitation Operations and the Street Cleaning Grant Program
- Encourage alternative waste solutions, such as onsite management, shared containers, and on-demand collection where feasible

With 885 unique addresses holding CLA permits—compared to 28,500 commercial area business licenses in 2025—this change will directly affect roughly 3% of businesses. Although fees are billed to haulers, they typically pass costs on to their customers. The proposed increase reinforces the City's commitment to maintaining high-quality public spaces and reducing the unintended impacts of waste infrastructure in shared urban areas.

Financial Implications

The aggregate impact of the overall fees increases is approximately \$9.0M in 2026. The main driver is Parking By-law fines, followed by Street Cut Repairs and Residential Parking Permit. GST, as applicable, will be added to taxable fees.

Legal Implications

The By-law annual rate changes and miscellaneous amendments are contained in Appendix B.

Part 4 – Pavement degradation cost

The permit holder must pay to the city, as a contribution to the cost of pavement degradation based on the total area of pavement excavated, the estimated cost of pavement degradation, as set out in the permit, calculated in accordance with the following table:
