2025-11-13	16:53	CD-1 Rezoning: 2090 West 1st Avenue	Oppose	To whom it may concern I strongly oppose this rezoning application on several grounds: There has been no plan for infrastructure development to support the planned population growth in Kitsilano. Specifically, there is no elementary school capacity at all in this catchment. Henry Hudson Elementary was just increased by 145 spaces, but was already overcapacity with a waitlist before the increase and is currently reported as at capacity. The Senakw development in this catchment will have 6,000 units by 2029 and no space for any children for elementary education. Approving additional development, such as this new proposal and the multiple others in Kits, is unethical in the absence of concurrent planning for support these new residents. Newly developed areas like Yaletown in the past, and Olympic Village currently, were developed without consideration of education access, forcing families to transport children outside of the catchment for education. This brings me to the next point. Transporting children generally requires cars. This new proposal, like all the others in this region is providing parking for only 46 units of the 176 planned. There will be lots of bicycle parking, but getting kids to school in the morning by bicycle daily is not realistic for most working parents. There isn't enough parking in the building and there is no available street parking already in the neighborhood. The only transit that passes close to this location is the number 2 bus to downtown, so even transporting kids to school by public transportation isn't realistic and again not feasibly practical for working parents. Arbutus street isn't going to have a bus travelling to and from the subway as the street is two narrow at the north end to accommodate a bus. Even with limited capacity for vehicles in the building and people finding parking somewhere else, traffic on First avenue will be chaotic.
