# 1. Vancouver's Social Housing Initiative

An application by the General Manager of Planning, Urban Design and Sustainability was considered as follows:

Summary:

To amend the Zoning and Development By-law to add a new relaxation and associated regulations to permit new social housing, which includes non-profit, non-profit co-operative, and government-owned social, supportive and co-operative housing to be built under a development permit application. No further Zoning and Development By-law amendments would be necessary to enable these projects. It also proposes a new rezoning policy to enable consideration of social housing proposals which do not fit into the standard zoning.

Amendments to the Heritage Conservation Area Official Development Plan (HCA ODP), including the First Shaughnessy Heritage Conservation Area Design Guidelines are proposed to enable and provide guidance for consideration of social housing rezoning proposals on all sites that do not contain protected heritage property.

The General Manager of Planning, Urban Design and Sustainability recommended approval subject to conditions set out in the summary and recommendation.

## **Summary of Correspondence**
