SUBJECT: CD-1 (409) Text Amendment: 1109-1139 West Pender Street and

1122-1152 West Hastings Street (Formerly 1128 West Hastings Street)

RECOMMENDATION TO REFER

THAT the rezoning application and plans, described below, be referred to Public Hearing together with the recommendations set out below and with the recommendation of the General Manager of Planning, Urban Design and Sustainability to approve the application, subject to the conditions set out below;

FURTHER THAT the Director of Legal Services be instructed to prepare the necessary zoning by-law, in accordance with the recommendations set out below, for consideration at the Public Hearing.

RECOMMENDATION FOR PUBLIC HEARING

- A. THAT the application by Jim Ralph of Pinnacle International (Hastings 2022) Plaza Inc. on behalf of:
 - The Strata Corporation of Strata Plan LMS4107 and the registered owners of the strata lots in Strata Plan LMS4107 as set out in Appendix D with corresponding civic addresses, PIDs and legal descriptions; and
 - ii. The Strata Corporation of Strata Plan LMS4114 and the registered owners of the strata lots in Strata Plan LMS4114, as set out in Appendix D with corresponding civic addresses, PIDs and legal descriptions,

to amend the text of CD-1 (Comprehensive Development) District (409) By-law No. 8439 for 1109-1139 West Pender Street and 1122-1152 West Hastings Street (Formerly 1128 West Hastings Street) to increase the total maximum permitted floor space ratio (FSR) from 7.92 to 7.93 to

allow for an addition to extend the mezzanine of the existing restaurant, to be approved in principle;

FURTHER THAT the draft by-law to amend the text of CD-1 (409) By-law No. 8439, prepared for the Public Hearing in accordance with Appendix A, be approved in principle;

AND FURTHER THAT the proposed form of development also be approved in principle, generally as prepared by Pinnacle International (Hastings 2022) Plaza Inc. received January 13, 2025 and supplemental plans received on April 29, 2025.

- B. THAT Recommendation A be adopted on the following conditions:
 - (i) THAT the passage of the above resolutions creates no legal rights for the applicant or any other person, or obligation on the part of the City, and any expenditure of funds or incurring of costs is at the risk of the person making the expenditure or incurring the cost;
 - (ii) THAT any approval that may be granted following the Public Hearing shall not obligate the City to enact a by-law rezoning the property, and any costs incurred in fulfilling requirements imposed as a condition of rezoning are at the risk of the property owner; and
 - (iii) THAT the City and all its officials, including the Approving Officer, shall not in any way be limited or directed in the exercise of their authority or discretion, regardless of when they are called upon to exercise such authority or discretion.

REPORT SUMMARY

This report evaluates an application to amend CD-1 (409) By-law for the Marriot Pinnacle Hotel site located at 1109-1139 West Pender Street and 1122-1152 West Hastings Street (Formerly 1128 West Hastings Street). This CD-1 text amendment proposes an increase to the total maximum floor area from 7.92 FSR to 7.93 FSR to allow for an addition to the existing restaurant. All changes resulting from the amendment would be contained inside the existing building footprint.

Staff recommend that the application be referred to a Public Hearing with the recommendation of the General Manager of Planning, Urban Design and Sustainability to approve it, subject to the Public Hearing.


REPORT

Background/Context

This application concerns the existing Vancouver Marriott Pinnacle Downtown Hotel which is a 36-storey mixed-use hotel/residential building located between Hastings Street and Pender Street, west of Thurlow Street (see Figure 1). The hotel was approved under the Downtown District (DD) zoning and was built in 2000. The site was rezoned to CD-1 in 2001, and subsequent amendments were approved in 2006 to allow for additional density within the hotel. The frontage is 95.9 m (314.7 ft.) along Hastings Street with a depth of 37.12 m (121.8 ft.).

Surrounding sites are zoned DD or CD-1 and developed with a mixture of office, hotel, service and retail uses.

The hotel tower consists of 446 rooms/suites, with 67 residential units on the upper floors, a four-storey podium with hotel functions, retail and amenity spaces and five levels of underground parking.



Strategic Analysis

1. Proposal

This text amendment proposes to amend CD-1 (409) By-law to increase the maximum permitted floor area from 30,473.5 sq. m (328,014 sq. ft) to 30,511.4 sq. m (328,422 sq. ft.). The proposed addition would increase the floor space ratio from 7.92 to 7.93. No changes are proposed that would increase the external size or volume of the existing building. As such, substantial changes to the existing form of development are not anticipated.

2. Height, Density and Form of Development

The *Hotel Development Policy* was updated in April 2025 to include significant measures to support the development of more hotels by giving existing hotels the opportunity to renew and expand. The proposed FSR increase is supportable as it aligns with the intent of the *Hotel Development Policy*.

3. Public Input

Public Notification – A rezoning information sign was installed on the site on May 21, 2025. Application information and an online comment form were provided on the Shape Your City (shapeyourcity.ca/) platform.




Figure 2: Overview of Notification and Engagement

Public Response and Comments – Public input is collected via online questions, comment forms, through email, and by phone. As seen in Figure 2, no submissions have been received.

4. Public Benefits

Community Amenity Contribution (CAC) – The application is subject to the *Community Amenity Contributions Policy for Rezonings* with CACs based on negotiations. The applicant has offered a cash CAC of \$17,000. Staff recommend that the offering be accepted and that the amount be allocated to fund public benefits in and around the Downtown and Metro Core Area. Payment is to be made prior to enactment of the CD-1 By-law, at no cost to the City and on terms and conditions satisfactory to the Director of Legal Services.

Development Cost Levies (DCL) – The site is subject to City-wide and Utilities DCLs. DCLs are payable at building permit issuance based on rates in effect at that time and the floor area proposed at the development permit stage.

Based on by-laws and rates in effect as of September 30, 2025 and the proposed increase of 37.9 sq. m (408 sq. ft.) in commercial floor area, it is expected that the project will provide approximately \$13,371 in additional DCLs.

DCL rates are subject to future adjustment by Council including annual inflationary adjustments. A development may qualify for 12 months of in-stream rate protection from DCL rate increases, provided that an application has been received prior to the rate adjustment. See the City's <u>DCL Bulletin</u> for details on DCL rate protection.

FINANCIAL IMPLICATIONS

As noted in the Public Benefits section, this project is expected to provide a cash CAC and a DCL payment. See Appendix E for additional details.

CONCLUSION

Staff support the amendment to CD-1 (409) By-law No. 8439 to increase the floor area from 7.92 to 7.93 FSR as it supports the renewal of an existing hotel and is consistent with the *Hotel Development Policy*.

The General Manager of Planning, Urban Design and Sustainability recommends that the application be referred to Public Hearing together with the draft By-law provisions, generally shown in Appendix A, with a recommendation that these be approved, subject to the Public Hearing.




