I encourage the City to work with the Squamish Nation and other partners to develop a shared plan for infrastructure, mobility, public amenities, and open spaces. I also encourage a more balanced mix of uses, including employment space and a hotel, to create jobs, support tourism, and build a vibrant neighbourhood rather than one that is primarily residential.
