SUBJECT: 125th Anniversary Grants Allocation, 2nd of 2 Deadlines

#### **RECOMMENDATION**

- A. THAT Council approve a total of \$247,000 in 125<sup>th</sup> Anniversary Grants—Large-scale Component—to 17 organizations as listed in Appendix A. Source of funds to be \$170,400 from the 2011 Cultural Grants budget and \$76,600 from the Cultural Tourism Strategic Planning Reserve.
- B. THAT Council approve a total of \$300,000 in 125<sup>th</sup> Anniversary Grants—Small-scale Component—to 53 organizations as listed in Appendix B. Source of funds to be the Cultural Tourism Strategic Planning Reserve.

Recommendations A and B authorize grants and require eight affirmative votes for approval.

#### GENERAL MANAGER'S COMMENTS

COUNCIL POLICY

Approval of grant recommendations requires eight affirmative votes.

#### **PURPOSE**

The purpose of this report is to recommend grants to 70 not-for-profit organizations for a total of \$547,000.

#### **BACKGROUND**

The groundwork for the City's 125<sup>th</sup> Anniversary celebration flows out of a Cultural Tourism Strategy planning process (RTS 6634) and subsequent Implementation Plan (RTS 7316) that began in spring 2007 and sought to build upon the cultural, economic and tourism benefits of

the City's existing large festivals and events, and new initiatives like the Juno Awards, the 2010 Olympic and Paralympic Arts Festivals and the City's 125<sup>th</sup> Anniversary Celebration. In 2007, Council approved an additional allocation of \$300,000 to a Cultural Tourism Strategy Reserve each year for four years starting in 2008 to leverage support with other agencies and funders. On July 6, 2010 (RTS 8271) Council approved the utilization of the Reserve, which subsequently helped to secure Vancouver's designation as a Cultural Capital of Canada in 2011. Now a cornerstone of our Cultural Tourism Strategy, the 125<sup>th</sup> Anniversary Celebration requires significant spending to implement our approved plans (including the 125<sup>th</sup> Anniversary Grants Program, Birthday Live, Summer Live and other civic programs). Throughout the year, the Reserve is being used to cover payables and receivables for this multi-pronged initiative. The City will re-coup, through external funding sources, up to \$1.75 Million from the Cultural Capital of Canada Program, \$109,200 from the Building Communities through Arts and Heritage - Community Anniversaries Program, and a projected \$600,000 from additional private sector sponsor support, which is currently being negotiated and/or contracted.

Council approved the creation of the 125<sup>th</sup> Anniversary Grants program on July 6, 2010. The large-scale and small-scale components of the grant program provide a point of access for community members to help the City celebrate its 125<sup>th</sup> anniversary of incorporation in 2011. The grant program forms a key part of a year-long Vancouver 125 celebration framework and is designed to provide direct financial support to new or enhancing existing events or initiatives that incorporate a 125<sup>th</sup> anniversary celebration component.

The grant program goals were informed by the Vision Statement created by the 38-member Celebrate Vancouver's 125<sup>th</sup> Advisory Committee. Over the spring and summer of 2010, the Committee set a high-level vision and framework for the City's year-long celebration:

Building on the momentum, energy and spirit generated during the Olympics, and through a growing awareness and understanding of our identities, first nations' heritage and cultural diversity, the people and neighbourhoods of Vancouver feel excitement, pride and enthusiasm for a celebration in recognition of Vancouver's 125th with activities that engage and enrich our society through the celebration of art and culture.

Significant awareness-building about the funding opportunity was undertaken between December 2010 and February 2011: Cultural Services staff held multiple public information meetings, sent e-newsletters to community members, placed paid (multi-lingual) ads in several local newspapers, and contracted an Outreach Coordinator to meet one on one with individuals and organizations from stakeholder communities. These outreach strategies directly led to the submission of 217 applications (including 90 first-time applicants) to the program. It has been Cultural Services' largest project grant intake to-date and significantly opened up access to and awareness of civic cultural grants programs.

#### DISCUSSION

The 125th Anniversary Grants Program was created to support the growing excitement, pride and enthusiasm for Vancouver's 125th anniversary. This program is a time-limited opportunity intended to foster awareness and understanding of Vancouver's identities, first nations' heritage and cultural diversity. This program supports activities that enrich our society through civic engagement and the celebration of art, culture and heritage. The specific program objectives are as follows:

 To support a spectrum of arts, culture, heritage and civically-focused activities which create excitement, pride and enthusiasm for the City's 125<sup>th</sup> anniversary;

- To facilitate new or expand upon existing cultural and community partnerships;
- To celebrate the creativity of Musqueam, Squamish, Tsleil-Waututh peoples and Vancouver's urban aboriginal population;
- To celebrate the creativity of diverse communities\*1 in a way that meaningfully represents Vancouver's current demographics\*2;
- To foster dialogue about civic issues that recognizes our City's built and cultural heritage and provides thoughtful planning for its future;
- To maximize opportunities for neighbours to celebrate in all of Vancouver's geographic neighbourhoods and distinct cultural communities; and
- To support high levels of creative merit and/or public community benefit.

The program is open to City of Vancouver-based, not-for-profit societies that demonstrate the capacity to produce, present, exhibit, or convene the initiative(s) during the months of January—December 2011.

#### **Assessment Committee**

As is consistent with all of its granting assessment practices, Cultural Services invites independent peer community members to participate in the assessment process to review grant application requests. Committee members are sought through an ongoing public call for nominations. For this intake the following independent peer members were:

Assessment Committee members join staff in reviewing grant requests against very specific evaluation criteria and form a consensus around priorities and recommendations for funding. Please see **Appendices C** and **D** for program information and evaluation criteria.

#### **Summary of Recommendations**

For this deadline, 217 applications were received for a total request of \$ 3,059,308. Three requests were withdrawn after the deadline. The recommendations in this report reflect a thorough review of each application in the context of merit, community impact and capacity. Not all organizations met the criteria at the same level as their peers. Furthermore, the

volume of applications led to an extremely competitive process, and with finite resources, not all requests are being recommended for support. As such, the Assessment Committee is recommending support for 70 projects totalling 32% of the projects under consideration.

#### FINANCIAL IMPLICATIONS

On July 6, 2010 (RTS 8271) Council approved the expense budget for the 125<sup>th</sup> Anniversary Celebration. On December 2, 2010 (RTS 8839), Council approved \$911,000 to 62 organizations in the first intake of this special projects grant program. From that total \$40,000 was retained as one successful applicant was instead fully funded by the City's Public Art Program. The \$40,000 was returned to the Cultural Tourism Strategic Planning Reserve.

In this current report, Council is requested to allocate a portion of the Vancouver 125 funding by approving grants to 70 not-for-profit organizations for a total of \$547,000.

The unallocated balance of \$292,000 in the 2011 New Cultural Grant Program budget will be fully expended in an upcoming report, Community and Neighbourhood Arts Development Program, scheduled for Council's consideration on May 31, 2011 (RTS 9055). The unallocated balance of \$257,400 in the Cultural Tourism Strategic Planning Reserve shall be used for 125<sup>th</sup> Anniversary programming (including Birthday Live, Summer Live and other civic programs) in 2011 (with spending approval provided in RTS 8271).

As a recipient of the Federal Government's (Department of Canadian Heritage) 2011 Cultural Capital of Canada Designation, the City will re-coup up to \$1.75 Million as part of its overall spending for the year-round 125<sup>th</sup> Anniversary programming. Of that \$1.75 Million, the Cultural Capital's Contribution Agreement will reimburse the City for \$230,000 towards the 125<sup>th</sup> Anniversary Grants Program, which will be returned to Cultural Tourism Strategic Planning Reserve.

#### **CONCLUSION**

The wide-spread outreach and awareness-building of this new, special projects program has resulted in an unprecedented number of new groups applying for grants for the first time. The Assessment Committee's expertise, insight, and carefully balanced evaluation has informed the recommendations in this report which propose to support a wide-range of projects fostering awareness and understanding of Vancouver's identities, first nations' heritage and cultural diversity. These recommendations will support the Celebrate Vancouver's 125<sup>th</sup> Advisory Committee's Vision Statement to support activities that enrich our society through civic engagement and the celebration of art, culture and heritage.

This program will support activities that enrich our society through civic engagement and the celebration of art, culture and heritage.

The program provides grants to not-for-profit organizations to commission and create works, to produce or present events or exhibits, to host one-time conferences or symposia, or to devise and implement anniversary legacy projects.

## **Program Objectives**

- To support a spectrum of arts, culture, heritage and civically-focused activities which create excitement, pride and enthusiasm for the City's 125<sup>th</sup> anniversary;
- To facilitate new or expand upon existing cultural and community partnerships;
- To celebrate the creativity of Musqueam, Squamish, Tsleil-Waututh peoples and Vancouver's urban aboriginal population;
- To celebrate the creativity of diverse communities\*<sup>3</sup> in a way that meaningfully represents Vancouver's current demographics\*<sup>4</sup>;
- To foster dialogue about civic issues that recognizes our City's built and cultural heritage and provides thoughtful planning for its future;

Performing art, studio art or writing and publishing commissions or creations: these are anticipated generally to be new works created for or inspired by the City's 125<sup>th</sup> anniversary or on themes of significant historical, contemporary or projected relevance to Vancouver's identity.

Production or presentation of new or expanded events or exhibits: these are anticipated generally to be temporary events or feature exhibits which are curated on the theme of the City's 125<sup>th</sup> anniversary or specifically expanded to include themes of significant historical, contemporary or projected relevance to Vancouver's identity.

Presentation of festivals or celebrations: these may be new events organized around the themes of Vancouver's 125<sup>th</sup> anniversary or they may be existing events which are significantly expanded or specifically themed in 2011 around the 125<sup>th</sup> anniversary.

**Publicity and marketing**: development and implementation of publicity and marketing strategies, and advertising and promotional expenses.

#### **Grant Fund Amounts**

The minimum grant is expected to be no less than \$10,001. The level of grant will depend on the proposed budget and scope of the project and how well it supports the program objectives and meets the evaluation criteria. The minimum project budget is expected not to be less than \$40,000 and all City contributions towards the project will generally not exceed 50% of the proposed budget.

#### **Evaluation**

Members nominated from the community participate on an Assessment Committee along with staff. Community members will have relevant expertise and experience in one or more of the following: commissioning, creating, producing, presenting, curating, publishing, or organizing significant public events. The Assessment Committee makes their recommendations based on how well the proposal meets and supports the program objectives, using the specific evaluation criteria outlined below. The proposals that best meet the program objectives will be given the top priorities for funding. All recommendations are considered, and given final approval, by Vancouver City Council.

#### **Evaluation Criteria**

#### Merit

- Clarity of intent and vision of the project as it relates to the City's 125<sup>th</sup> anniversary program objectives;
- Strength and rationale of project partnerships, if they are proposed;
- Experience of the key creative personnel involved and quality of their work as demonstrated through past projects, training or experience;
- Level of creative merit and/or public community benefit; and
- Distinctiveness of the project in the spectrum of arts, culture, heritage and civically-focused activities proposed for the City's 125<sup>th</sup> anniversary.

#### **Impact**

- Degree to which the proposal maximizes opportunities for citizens and visitors to celebrate in Vancouver's geographic neighbourhoods and/or distinct cultural communities;
- Degree to which the proposal facilitates new or expands upon existing cultural and/or community partnerships;

- Noting the short timeline to implement new projects or expand existent ones before December 2011, that realistic planning is in place.

In addition to the above criteria, because the Celebrate Vancouver's 125<sup>th</sup> Advisory Committee envisioned celebrations taking place in all of Vancouver's neighbourhoods, geographic distribution of the proposals may come into consideration when assessing the requests. - Distinctiveness of the project in the spectrum of arts, culture, heritage and civically-focused activities proposed for the City's 125<sup>th</sup> anniversary.

### **Impact**

- Degree to which the proposal maximizes opportunities for citizens and visitors to celebrate in Vancouver's geographic neighbourhoods and/or distinct cultural communities;
- Degree to which the proposal facilitates new or expands upon existing cultural and/or community partnerships;
- Degree to which the proposal provides opportunity for celebration of the creativity of Musqueam, Squamish, Tsleil-Waututh peoples and Vancouver's urban aboriginal population;
- Degree to which the proposal provides opportunity for celebration of the creativity of diverse communities in a way that meaningfully represents Vancouver's current demographics; and
- Degree to which the proposal fosters dialogue about civic issues that recognizes our City's built and cultural heritage and provides thoughtful planning for its future.

- Degree to which the proposal promotes new or expands existing cultural and/or community partnerships;
- Degree to which the proposal provides opportunity for celebrating the creativity of Musqueam, Squamish, Tsleil-Waututh peoples, Vancouver's urban aboriginal population, or Vancouver's diverse communities, if it is proposed;
- Degree of community support and involvement—for example, expected public attendance, volunteers, participants or donation levels; and
- Degree to which the proposal fosters an exchange of ideas about our City's built or cultural heritage or provides thoughtful planning for its future.

- Evidence of the organizers' skills and expertise to carry out the project;
